#### TARUN SAGAR JI URGES PEOPLE TO STOP CONSULTING ASTROLOGERS AND TANTRIKS



New Delhi, March 29: Environmental journalist and editor of the magazine, 'Down To Earth', Sunita Narain was today conferred the Chameli Devi Jain Award for Outstanding Woman Mediaperson for being a "tireless crusader for environmental rectitude". At a function held at India International Centre, Narain was handed over a citation. The citation said that Down To Earth brought out by the Centre for Science and Environment, Delhi, "has been at the forefront of those who have brought environmental issues into the mainstream of national and household consciousness".

"Recent campaigns conducted by Down To Earth," the citation added, "have focused on air and water quality, pesticide and other toxic residues in the food chain, water conservation,

especially through rainwater harvesting, and equitable and ecologically sound methods of waste disposal." Narain pointed out that environmental and ecological issues in rural and urban India had grown more complex over the years. "Down To Earth is not mainstream, neither is it as staid and boring as alternate media is supposed to look," she added. The award ceremony was followed by a panel discussion on "Who Rule Airwaves" in the context of the 1995 Supreme Court ruling that airwaves should not remain a government monopoly.

The author meticulously covers different aspects of Jain Art, Architecture and iconography as found in Madhya Pradesh from 9th to 15th centuries CE. The work has been presented in a very comprehensive manner. There is a pull out map of Madhya Pradesh, 26 line drawings and 102 art plates, which have b/wcolour photographs. #### JAINS IN TN WANT TO BE DECLARED AS 'RELIGIOUS MINORITIES' IN TAMILNADU

Jains in Tamil Nadu have demanded that they should be declared as 'religious minorities' in the Tamil Nadu. According to Mr. Harish Mehta, Member of the State Minorities Commission, Jains are allowed to run educational institutions as minority institutions, but have to approach the Government every year for renewal of their minority status. Mr. Bharwarial Gothi, President of Shree Jain Maha Sangh has also demanded that, the Mahaveer Jayanti should be declared a holiday under the Negotiable Instruments Act in the state. The day should also be declared as 'Ahimsa day' so that order can be issued for the closure of all meat shops on this day.

#### MUMBAI HIGH COURT REJECTS PETITION FOR STOPPING BAL DIKSHA

The High Court observed that as per the Jain religion bal diksha is an acceptable tradition and therefore the petition filed is rejected. A petition was filed in the Mumbai High Court by some persons for the stoppage of all Bal Diksha programmes by law through a writ petition number 3272/2004. The case was heard by two member bench of Justice (Mr.) V. G. Paslikar and Justice (Mrs.) Nishita Mahatre. The deciding bench also referred to a similar case in Rajasthan High Court (1998), where it was observed that conferring diksha without any force or compulsion is acceptable. Since no complaint is made and everyone has willingly participated in the programme, the petition cannot be accepted.

## C. B. I. TAKES UP ENQUIRY INTO DEPLETING NUMBER OF TIGERS



The Central Bureau of Investigation has constituted an enquiry into the report received from the Ministry of Forest and Environment about the sudden depletion in the number of tigers in the Sariska national sanctuary. An enquiry committee has been formed by the C. B. I. to carry out preliminary investigations. A detailed enquiry will be conducted after receiving the report from this committee. However, it is understood that tigers are disappearing in Uttaranchal also and this information has become a cause of concern for the environmentalists. According the figures published in the press, the total number of tigers in the year 2001 was 251, whereas, in 2003, the number is 245.

#### **REGRETTABLE**

#### SAM JAIN CHARGED FOR SOFTWARE PIRACY BY SYMANTEC SOFTWARE IN US

Symantec has been granted a default judgment of \$3.1 million against Sam Jain for selling counterfeit Symantec software and violating Symantec's intellectual property rights. Specifically, the judgment, handed down by the United States District Court for the Central District of California, found in favor of Symantec against Jain for trademark infringement, copyright infringement, false designation of origin, and unfair competition. In addition, the Court enjoined Sam Jain and anyone acting in concert with him from infringing Symantec's intellectual property rights again in any way or from further misleading consumers in the future by using representations or imitations of genuine Symantec trademarks, service marks or copyrighted materials.

The award had concluded legal action in the case filed by Symantec against Jain and others in April 2004. In the suit, Symantec had alleged that Jain and his co-defendants used pop-up ads that misled consumers into believing that their Symantec software was about to expire and needed to be renewed to maintain functionality. Symantec also alleged

that some of the pop-up ads re-directed unsuspecting consumers to a Web site selling the defendant's own software.
