





ARCHEAOLOGICAL SURVEY OF INDIA ORDERS DEMOLITION OF SANCHI JAIN TEMPLE

VIDISHA: A good deal of tension prevails in Jain Samaj after the Archaeological Survey of India gave demolition order of Sanchi Jain temple. Although the district administration has not taken any decision over the demolition of the temple but the Jain Samaj representatives while condemning the decision took the matter seriously. It may be mentioned here that the Director General, Kasturi Gupta Menon of GOI's Archaeological Survey of India has written a letter to archaeology department asking them to demolish the Shitalnath Digambar Jain Temple of Sanchi which was illegally constructed within 15 days time. In this connection, Sheetalnath Digambar Jain temple trust chairman, Deepchand Jain and general secretary, SP Jain have in a release stated that not even an inch of the archaeology department or the government land has been encroached but on the contrary the same has been constructed with the permission of Collectorate under the Public Religious Buildings Act 1984. BJP national secretary and MP Shivraj Singh Chauhan raised this issue in the presence of Prime Minister, A.B. Vajpayee, Deputy Prime Minister, L.K. Advani, Union Tourism Minister Jagmohan and BJP national president, Venkaiah Naidu. Union Minister of State, Ms. Bhavana Behn later gave necessary orders to the ASI asking it to withdraw its order. JAIN BODY DEMANDS PART IN AYODHYA EXCAVATION - PRESS TRUST OF INDIA



Jodhpur, March 11: A social organisation of Jains which has staked claim over the disputed land in Ayodhya, where the Archeaological Survey of India is undertaking excavation on a court's order, on Tuesday demanded that а representative of the Jains be allowed as observer while

the excavation is on. A team of four representatives of Hindus, Muslims, Buddhists and Jains should be formed and allowed to witness the excavation by the ASI to ascertain if a temple existed on the site where Babri Masjid was built, Jain Samta Vahini said in a statement in Jodhpur.

The JSV demanded that it be made a party in the on-going legal battle to settle the issue because "historical records showed that the disputed structure stood over a Jain temple". Mr. Praveen Kumbhat, National General Secretary of the JSV said it remained aloof from the ticklish issue so far as it was being sought to be resolved by violent means by certain quarters, but it decided to become a party in the dispute when judiciary decided to find what lay beneath the foundation of the disputed structure. They have immense antique as well as spiritual value. Mr. Dilip Gandhi(Jain) Minister of Shipping, Government of India has taken up this unfortunate incident with the Chief Minister of Haryana, Mr. Om Prakash Chautala and Minister of State for Home Affairs, Mr. I.D. Swamy. The Haryana Administration has assured Jain community that they the culprits shall be caught and punished soon.



RISE ABOVE GROUP INTERESTS FOR NATIONAL UNITY SAYS PRESIDENT



The law and order authorities appear to be totally ineffective in preventing these incidents, not appreciating the immense loss being incurred to the ancient heritage of the country. Recently, six brass idols are reported to have been removed from a temple at Sawai Madhopur in Rajasthan. The devotees, on reaching the temple in the morning for darshan found that the six idols were missing from there. The matter was immediately reported to the Police. It is learnt that the thieves had entered the temple through a ventilator by breaking the iron bars. No arrests have so far been reported.

1. Jain Queen Of Karnataka Veera Rani Abbakka : The brave Queen of Chowla family of Jains, Veera Rani Abbakka Devi ruled in Ullal of Dakshina Kannada during 1954-1640. She was the first Indian brave warrior Queen who fought against the Portuguese for independence and restored it throughout by driving away the Portuguese, whenever they invaded the costal area of Dakshina Kannada. PETA WINS RELIEF FOR CIRCUS ANIMALS IN MISERY

Mumbai : As part of a lawsuit filed by People for the Ethical Treatment of Animals (PETA) against the State of Maharashtra and the Empire Circus, Chief Justice Mr. C. K. Thakkar and Justice Mr. Chadrachur ruled that until the case is settled the animals banned from performing should be sent to a rescue center. Additionally, the performances by the other animals are to stop because the circus does not have registration with the Animal Welfare Board of India (AWBI), which is required by law. The judges noted that since the animals were not allowed to perform they should not be forced to suffer. PETA represented by Advocate Mr. Pradeep Rajagopal, had filed a Public Interest Litigation (PIL) in the Bombay High Court in November 2002. By the order of the court, the animals can now be moved to Nahargarh, a rescue centre outside Jaipur where they will live a better quality of life, till the final judgment is made. LAW SUITE FILED AGAINST MR. NAVEEN JAIN BY INFOSPACE, USA




Wireless and Internet software provider InfoSpace, USA has filed a lawsuit against its founder and director, Naveen Jain. The lawsuit alleges that Jain and former InfoSpace chief software architect, Kevin Marcus, violated their agreements after forming software company Intelius earlier this year. Jain serves as Intelius' chief executive and Marcus as its chief technology officer. The two men are joined by other former InfoSpace employees and former Microsoft senior executives at the young company. The lawsuit, filed in King County Superior Court in Seattle, alleges that Jain and Marcus violated their noncompete agreements with InfoSpace, misappropriated trade secrets and confidential information, and interfered with InfoSpace's contractual

relationships. Jain remains an InfoSpace director. A company representative said Jain has not tendered his board resignation since the lawsuit was filed. The company provided no further details on its lawsuit. Jain, however, contends the lawsuit is without merit.

CHENNAI'S ST. THOMAS CHURCH WAS A JAIN TEMPLE?

WAS FATEHPUR SIKRI BUILT BY AKBAR OVER HINDU AND JAIN TEMPLES? RESEARCH BY ASI CONFIRM THE BELIEF



New Delhi : Did Akbar build Fathepur Sikri over a temple? According to the recent excavations by the Archaeological Survey of India, the heritage city not only rests over a temple, but the state of the idols excavated also point towards mutilation and defacement. According to D. V. Sharma, Superintending archaeologist, ASI "the fracture marks on the statues proves they were defaced by chisels and hammers and there is evidence of a demolition of a temple."

Presenting the findings of his excavations in an illustrated talk here on Tuesday, Sharma showed slides of the remains of a temple under Bir Chhabili Tila, a mound near the monument along with the existence of a water palace under the Anup Talao, within the premises of the monument. The ASI team which began its excavation since December has discovered mutilated Jaina images, including the remains of a temple with rubber masonry and mud mortar walls measuring 1.35 metres in width.

More important is the discovery of an idol of Goddess Sarasvati with an inscription on its pedestal. According to Sharma, the sculpture, in a standing tribhanga posture, was fixed on a pedestal and was found damaged at its foot, placed with its face downwards near a wall. "The circumstantial evidence, supported by the marks near the foot suggest that the believers tried to uproot and remove the sculpture in advance," says Sharma. The inscription dates back to 1010 A.D. and this statute "in Jaisalmeri stone is quite unlike the usual murtis of Saraswati which are generally cast in marble," he explains.

Beneath the Anup Talao, the team has also found a huge jar, 12 feet high and 8 feet wide. "We have named it Ganga Sagar, because it was used for storing Ganga water, during Akbar's time too," says Sharma. Matching the dramatic tenor of the ASI excavations was the reaction that followed the talk. know if the ASI had any policy on "ripping apart" ancient monuments which were part of the national heritage. "We all know that India is a rich and ancient country, built on layers and layers of civilisation. There could be a temple beneath the Taj Mahal too. Will the ASI dig that up too?" he queried. Sharma however insisted, the effort was not to destroy the present heritage but only to find out the truth. "We are here to correct the interpretation of palaces and monuments, not to rip apart monuments," he elucidated. But the fact thet the matter had already become politicised was evident, when the Chairman of the Indian Archaeological Society, S P Gupta, circulated a paper on the excavations which concludes: "There is ample proof of (a) the destruction of the Jain temple, (b) the sculptures being vandalised without exception. There is no evidence of Hindu vandalism at the site. What is the other language of this destruction if not 'demolishing temples' by the
