



#### **SANTHARA OR SUICIDE?**

Jaipur: Seventy-four-year-old Amar Chand Kasawan has attained divine status according to the Jain community. After suffering from gangrene and pneumonia for a long time, he took up Santhara, a religious ritual of fasting unto death. Kasawan died on the fifth day of his fast but instead of mourning, the family will glorify his death.

"This is a religious fast and my father-in-law really wanted to take it up," Kasawan's daughter-in-law, Kalpana said. This is not a stray incident in the community. Before Kasawan, 61-year-old Vimala Devi died last week after fasting for 14 days. A petition has been filed in the Rajasthan High Court, equating the practice of Santhara with the likes of suicide, euthanasia and Sati. Like Vimala Devi's family, Kasawan's family, too, justifies it by claiming that it was a wish, which he

had expressed in his diary 15 years ago. "When the doctor gave up on him he told us 'now you take me home and fulfill my last wish'," Kasawan's son, Vimal said. Three other cases of Santhara have been reported from Rajasthan, all of them being women over 80 years old. The Shwetambar sect of the Jain community considers this practice to be the ultimate spiritual achievement. However, the Rajasthan High Court will hear a Public Interest Litigation challenging the practice of Santhara. In the last one week five cases of Santhara have been reported in Rajasthan, of which two people have died since the filing of the PIL.

# CONTROVERSY OVER SUPREME COURT DECISION FOR CONTROL OF RISHABH DEV TEMPLE AT KESARIA JI CONTINUES. - A REPORT

The decision of the Supreme Court about the management and control of Shri Rishabh Dev temple at Kesaria Ji near Udaipur in Rajasthan (reported in the February issue of Ahimsa Times) to the effect that the temple belongs to Jain community only and the question of its control amongst Swetambar and Digambar sects should be decided by the State Government still remains to be implemented. There are three parties involved in the controversy, (i) Jains, (ii) Hindus living in the town and near-by including the priests and pandas who have been performingworship of some Hindu idols installed in the temple premises and (iii) the local adivasi population, who claim that Rishabh Dev is their God and they have

been worshipping the same since long with all the reverence. The Supreme Court decision should have put put the whole controversy at rest, giving the right of management and control to the Trust owned by Jain community). However, the Hindu population there did not relish the decision of the Supreme Court, thinking that their authority would be lost and therefore the Adivasi community was misled and told by the vested interest that they would no more be able to enter the temple and perform worship of their beloved God, once the control goes into the hands of Jains. The mis-understanding so caused, led to clashes between the two communities, which resulted in death of one Adivasi and injury to many persons on both sides. The ugly situation was, of course, soon controlled by the local authorities and tight security was placed over the temple premises and near-by areas. Repeated assurances were also given to Adivasi people that they would always be free to enter and perform worship as and when they wanted. Still, the differences wwere not fully resolved. In the mean time, the two main sects of Jain community, Swetambar and Digambar, came out openly, each of them claiming their right over the management of the temple.

Looking at the growing dissention amongst the two sects as well as the continued demand of other communities over the control of the temple, the State Government felt that it was not possible to hand over the charge of the temple to the Jain community, and so it has expressed its inability to the Supreme Court to implement its decision, as announced in Vidhan Sabha by the Minister for Parliamentary Affairs, Mr. Rajendra Singh Rathore. The State Government has filed a petition for the review of the decision, keeping in view the prevailing situation. In the mean time, the Adivasi community as well as the Hindu population have found it as opportune time to submit a review petition from their sides. It is worth-mentioning that there is no justification for Hindus or Adivasis to claim the control over the temple as the right to manage the temple had been decided as far back as in the year 1922 by the then courts and

the same had been confirmed and re-confirmed many times in the past, observing that the pilgrims from all over the country come in large numbers to pray their first Tirthankar, Rishabh dev Ji and the large majority of devotees coming to the temple are Jains, both Swetambar and Digambar.

It is however unfortunate that at this critical juncture, that Jains can not settle their differences on this common issue and to bring it in open, thereby weakening their own claim over the temple. It is high time that both the sects realise the serious damage that is being caused to the entire Jain community by their egoistic stands and frivolous claims. It can not be explained why both parties can not sit together and arrive at a just and fair solution, suiting to both sides, may it be control over the trust revenue, differences in the mode of woeship or rituals or the management of the temple. Why a common trust, owned by both the sects, having members fom both sides can be not created? It can be possible if both sides have a will to do so, with a sense of mutual respect, understanding and sacrifice. If the people concerned can not come to an understanding and go on singing their own tunes, they have no business to talk of aparigraha, anekantwad and ahimsa and call themselves as Jains.

#### **CULTURE MINISTRY CONSULTS CBI TO CURB ANTIQUE THEFT**

New Delhi, March 19 Concerned over increasing theft of country's priceless antiques, the culture ministry is consulting the Central Bureau of Investigation for effective preventive measures and planning to amend the Antiquities and Art Treasures Act, 1972, to make punishment for offenders stringent. 'CBI is the most efficient agency and they can handle this matter. Diplomatic missions are also requested to be in touch with the respective countries to evade illegal smuggling of these articles. In January this year, 10 precious idols were stolen from a Jain temple in Gurgaon, on the outskirts of Delhi.

A 900-year-old idol, stolen from a temple in Uttar Pradesh, was recovered in Delhi and two persons were arrested earlier this month. In another incident, three 700-year-old Jain idols costing Rs.130 million on the international market were recovered in Delhi last week from a man who allegedly planned to smuggle them out of the country.

According to Archaeological Survey of India Director General C. Babu Rajeev, The government has already signed an agreement with China to stop illegal smuggling of these heritage items. Such agreements with other countries are in the pipeline. India has a record of only 450,000 antiques but expressed confidence that the country is an inventory of millions of such artefacts. Dialogue is also on for getting back one sculpture of Thirthankar from Washington, one sculpture of Nataraj from London and one sculpture of Varah from Switzerland. While launching the National Mission on Monuments and Antiques, Tourism and Culture Minister Ambika Soni said her government is planning amendments to the Antiquities and Art Treasures Act, 1972, to make the provisions more stringent with a view to curbing illegal trafficking in antiquities. The temple complex lies on 378 hectares of land and houses a guest house as well. Its moveable property alone is said to be valued at about Rs.51 crores. It is estimated that on an average 2,000 devotees visit Rishabdeo every day. The temple's eight Brahmin priests share the bulk of the offerings. # JAIN TIRTHANKAR IDOL CHANGES COLOR IN JABALPUR

Mar 6: When everyone was busy playing Holi with colours on Holi, an idol in a Jain temple in Jabalpur also underwent a colour change. The nine-inch high idols of lords Shanti Nath and Mahaveer lost their

silvery shine and turned golden during a ritual performed as part of a seven-day function at the Jain temple in Agrawal Nagar. Jain community devotees thronged the temple as news spread like wild fire. It was during the conclusion of a religious ceremony that some one noticed the colour change and brought it to light. Many who viewed the Idol before accepted that Chintamani Parsvnath had indeed changed his colour.

This is nothing short of a miracle, in fact it is a miracle. The idol is made from an alloy of eight metals and originally is silver in colour, but according to eyewitnesses, it has turned golden. The upper torso of the idol that is the head and chest has turned its colour while rest of the idol is still silver. A large number of devotees also took out a procession carrying the idol on the streets of Jabalpur.

Devotees carried the idols during the procession as people thronged the area to catch a glimpse of the idols. Several dignitaries including local BJP MLA Sharad Jain also offered prayers before the idols. As temple remained abuzz with activity, members of the scientific community are yet to comment on the claim made by the Jain community.

# ONE HELD FOR ROBBING JEWELLERY FROM KANDIVLI JAIN TEMPLE

Four days after valuable jewellery was stolen from a Jain temple, the Kandivli police claim to have arrested one of the three robbers. However, they have not recovered the loot. According to the police, Sanjay Yadav along with two others, hatched a plan to rob the gold and silver jewellery adorning the idols in a Jain temple at Irani Road, Kandivli, Mumbai. On March 1 evening, Yadav and his accomplices allegedly entered the temple on the pretext of performing a puja. They allegedly removed the gold crowns and necklaces despite the presence of closed-circuit cameras and tight security. It was easy for them to rob as anyone could approach the idols and perform puja. Later the devotees noticed some ornaments missing. CCTV pictures provided the identity of culprits and the arrest was made.

#### HINDUS AND BIG BUSINESS FIGHT OVER 'PROMISED' LAND OUTSIDE TEMPLE IN PAKISTAN



KARACHI: A Hindu temple located under native jetty bridge has become the focus of what is developing into a battle between two groups - the Hindus who worship there and the firm that wants to build a food street next door. Not lagging far behind are the political agents who bring the two together. The dispute is not actually over the temple, but the 5,750 square feet area in front of it that the worshippers use on special occasions when their numbers increase. Now, the company building the food street wants to erect a boundary wall in front of the mandir.

The ground will be left empty but the company expects to landscape it and leave it as an open space for the people who visit the food street. Some of the Hindus argue, however, that by building a boundary wall between the mandir and the ground, the company will be effectively cutting off the space that they use. The land in question belongs to the Karachi Port Trust. A eight-member committee was formed to tackle the issue.

The committee consists of the president, secretary and general secretary of the Hindu Panchayat. The meeting was attended by Advisor to Prime Minister on Minorities, Kishan Chand Parwani, Pakistan Hindu Council General Secretary Visharam A. Tharwami, Hindu Panchayat President MPA Mukesh Chawla and MPA Dr. Ramesh Kumar amongst others. Some of the Hindus are also objecting to the food street as they are vegetarians and the smell of cooking flesh right next door would be offensive to them. A large number of Hindus protested outside the Karachi press club claiming that the mandir had been partly demolished. The protest was led by ex-MNA Dr Khatumal Jeewan, PPP minority wing President Prof. Anwar Lal Din and the Mandir Bachao Committee's Ashok Jethmalani. Each week there is a gathering and on big religious occasions such as Raksha Bandhan and Ganesh Janti large statues of the deities are brought the mandir. There were allegations that MPA Mukesh Chawla permitted the construction to go ahead without consulting the Hindus at a gathering. Certain worshippers denied that any part of the mandir had been demolished.

# SUPREME COURT ACCEPTS THE PETITION FOR ALLOWING PEOPLE LYING ON DEATH BED TO DIE, IF THEY WISH



The Hon. Supreme Court has accepted a petition submitted by a non-government organisation, named "Common Cause" praying to allow such persons, who are suffering gravely and are lying on the death bed to die willfully in order to relieve themselves from pain and agony for ever. It is interesting to know that in many developed countries, the law of the land allows such persons to die peacefully, who are suffering from ailments which are beyond any treatment, as certified by doctors. In our case, however, no such law exists. Even though the Supreme Court has accepted the petition for consideration, the Government of India is opposing the request on the plea that such a provision in the law could be liable

to be mis-used by people who may want to get rid of the sick persons, even though their condition may not be so grave.

#### INDIAN MONEY-LAUNDERER NARESH JAIN ARRESTED IN DUBAI

In one of the biggest crackdowns against Indian money-launderers abroad, the Dubai police last week arrested seven Indian nationals, including Cofeposa absconder and Dawood associate Naresh Chandra Jain, and froze the banks accounts of at least 21 expatriates for allegedly transferring the dirty money of politicians and industrialists abroad.

Launching a synchronised operation against the accused and their beneficiaries across several countries, the UAE authorities have instructed all banks and financial institutions to freeze the accounts of the tainted persons who have also been found financing terrorist organisations. The drive marks a very high degree of co-ordination among the agencies of different countries to enforce the curbs devised post-9 /11 to check money laundering and choke the flow of funds to terrorists and crime syndicates. The arrests were made on a tip from US investigating agencies that had been keeping a close watch on Jain and some of his Dubai-based relatives for their alleged association with the D-gang and for allegedly funding Al Qaida operatives.

The UAE and US authorities have already apprised India's external intelligence agency, the Research & Analysis Wing (RAW), and handed over CDs and some sensitive documents containing the transaction details of the Jains with key Indian politicians and industrialists. Sources said Jain was on the radar of US intelligence ever since he was spotted at the marriage of Dawood's daughter in Dubai in 2005. He had also allegedly been using his hawala network across continents to facilitate the financial transactions of Dawood's narcotics trade.

# MANGALORE CITY CORPORATION STARTS CAMPAIGN: 'DON'T KILL HARMLESS STRAY DOGS'

Mangalore: The Mangalore City Corporation (MCC) is all set to cull stray dogs in the City following the footsteps of Bangalore. In the wake of apprehensions that the dog catchers will set foot on the City, the animal lovers of the city have come out with a solid action plan for protecting the stray dogs that are not ferocious.

The compassionate, merciful people of Mangalore, under the aegis of Animal Care Trust, an NGO recognised by the Animal Welfare Board of India, has come out with a resolution demanding the MCC not to kill healthy dogs, sterilisation and vaccination of stray dogs on war-footing basis.
